## **Texas Lien & Notice Fact Sheet**



This fact sheet explains who can file a mechanics lien on private construction projects in Texas, and how to secure your right to file a lien. This download includes a preliminary notice template and a proof of service template.

### 1. Who can file a mechanics lien in Texas?

People or businesses who provide work or materials to improve a property. This includes:

- Direct Contractors
- Subcontractors
- Material Suppliers
- Equipment Lessors
- Design Professionals
- Laborers
- Equipment Lessors

### 2. Is preliminary notice required?

Texas has particularly complex notice requirements that must be met to protect lien rights.

Failing to provide required notice on time may be fatal to a mechanics lien claim.

#### 3. When is the notice deadline?

2nd Month Notice must be delivered by the 15th day of the 2nd month following the month in which labor or materials were provided. For example, if you performed work in January, notice is due March 15. 3rd Month Notice follows the same convention, but send after 3 months rather than 2.
